

# OBAZU YOUTH APPRENTICESHIP PROGRAM

## VENDOR AGREEMENT

This Agreement (the "Agreement") is entered into as of: \_\_\_\_\_ (the "Effective Date")

### RECITALS:

WHEREAS, the Obazu Youth Apprenticeship HBC wishes to engage the aforementioned Vendor under the terms below and WHEREAS, the Vendor wishes to provide the Services in accordance with the terms of this Agreement; the Parties hereby agree as follows:

### SERVICE TO BE PERFORMED:

- Vendor will accept and train the following Youth Apprentice: \_\_\_\_\_ in the following skill area: \_\_\_\_\_ for a period of \_\_\_\_\_ months or as necessary to fully master the skill and pass any required trade exam in order to start the trade.
- Upon completion of training, Vendor agrees to provide the Youth Apprentice a list of all tools required to start trade and assist in any way they can to help the youth apprentice begin the trade.

### NATURE OF RELATIONSHIP:

• The nature of this relationship is independent contractor status. No employment relationship or business partnership is intended or implied by this agreement. The Vendor agrees to perform the services hereunder solely as an independent contractor for the payment and consideration received.

- Vendor shall provide supervision, equipment, training, tools, and all supplies during the course of training.
- Vendor affirms that they have the knowledge, tools and skills required to train the youth Apprentice placed under their care and will act in good faith to ensure successful training of the Apprentice.

### TERMS OF AGREEMENT.

- Compensation Structure: vendor will be compensated as follows: (i) The specified "Ihe Ome n'ala" plus 50% at the beginning of training AND (ii) Remaining 50% upon completion of training.
- If for any reason, the apprentice is unable to continue or finish training, vendor agrees to accept an alternate youth to complete training in order to receive payment.
- Vendor Default: If vendor terminates agreement, defaults or fails to perform according to the agreed terms, Obazu Youth Apprenticeship HBC will make no further payment to vendor and may seek legal and other remedies to recover any payment made to vendor.

This non-exclusive Agreement shall become effective as of the "Effective Date" above and may be terminated by Obazu Youth Apprenticeship HBC with or without cause by giving a written notice to vendor. In event of termination, vendor shall be required to release youth apprentice without any penalty or payment obligation.
